Opinion

We have audited the Statement of Net Capital Balance of **Value Stock and Commodities (Private) Limited** (the "Securities Broker") and notes to the Statement of Net Capital Balance as at June 30, 2018 (hereinafter collectively referred to as "the statement").

Our opinion is not modified in respect of this matter.
